## **Position Description**

Legal Services of the Hudson Valley (LSHV) has an immediate opening in our White Plains office for a Financial Analyst in our Finance Department who will prepare and submit financial reports from the general ledger, with associated supporting detail, for reimbursement by state, local and federal funders and foundations. The Financial Analyst reports to the Reporting Manager.

Responsibilities include but are not limited to:

- Preparing financial reports by funder for reimbursement of services provided and expenses incurred
  - Supporting Finance and Accounting in the reporting process in coordination with Payroll and Accounts Payable and providing accurate invoices, requesting for reimbursement and reports to the grant funder.
  - Assisting the Reporting Manager in reconciling hours and payroll reports and ensuring they are meeting the budgeted amount in the grant.
  - Requesting supporting documentation from accounts payable in the format that is required by the funder
  - Supporting the Reporting Manager in monthly reporting
  - Interacting with sub-contractors to ensure that all reports are submitted on a timely basis
  - Submitting payment requests for reimbursement of funders, and following up regarding payment
- Preparing budgets for new and existing funders
- Assisting others in Finance and Accounting department, as needed
