OVER 50% OF OUR CLIENTS IDENTIFY AS BLACK OR HISPANIC, 70% ARE FEMALE AND 23% ARE SURVIVORS OF DOMESTIC VIOLENCE; 49% OF CLIENTS ARE DISABLED AND CLOSE TO 36% ARE ELDERLY. OUR CLIENTS ARE AT OR BELOW 200% OF THE FEDERAL POVERTY GUIDELINES (\$69,376 FOR A FAMILY OF FOUR IN 2021). IN 2021, LSHV HANDLED CLOSE TO 12,000 CASES IMPACTING OVER 27,300 HOUSEHOLD MEMBERS THROUGHOUT THE SEVEN-COUNTY SERVICE AREA.
