A Message from Our CEO

2021 was a year that tested our organizational resiliency in a time of rapid change. Throughout the pandemic, our staff have been the "emergency responders" of the legal profession. Our waiting rooms are filled with community members who are at risk of becoming homeless, fleeing dangerous home situations, trying to figure out how to feed their families, and whose basic necessities are in jeopardy. We must triage cases, trying to best utilize our limited resources. For every person we assist, we have to turn away two to three others who need our help. LSHV staff are often the repository for the stress, helplessness and trauma our clients experience. In order for our clients to access justice, we must challenge systems that are unjust and inequitable on a daily basis.

Despite these challenges, we marked 2021 with many impressive accomplishments. Most notably, we handled 11,681 legal matters; answered 14,798 calls to our Central Intake Hotline; created seven Know Your Rights Videos; and launched a new interdisciplinary Family Defense Unit including our first social workers. We also completed our 2022-2024 Strategic Plan, which is an ambitious and aspirational road map for how LSHV will combat the institutional oppression that plagues our communities.

Some of our other notable accomplishments include:

- Awarded **\$5.6 million in funding** to expand eviction defense legal assistance;
- Provided 7,500 hours of volunteer legal assistance through 125 active pro bono attorneys;
- Added six new Board Members resulting in increased diversity on our Board of Directors:
- On-boarded 47 new staff;
- Created an organizational Equity Plan;
- Signed up 111 staff to participate in Spanish language classes;
- Moved into **new office space** in White Plains and Nanuet; and
- · Launched a new fully accessible website.

None of these accomplishments would have been possible without the tireless commitment and devotion of our superb staff, who share the common mission of creating equal access to justice, regardless of income. Their resiliency in overcoming many obstacles this year, reinforces the essential role civil legal services continues to play in supporting and healing communities post-pandemic.

Finally, I am grateful for the resiliency of our donors and supporters. You have remained steadfast in your generosity through virtual fundraisers, hybrid events, and everything in between! Looking to the future, I am confident that our staff, community, and donor resiliency is strong and enables us to face the challenges ahead of us in our path to realize justice for all!

Central Intake Unit

LSHV's Central Intake Unit is currently staffed by seven full-time paralegals who spend every day answering calls to our toll-free intake line and responding to online requests for assistance submitted through our website. The intake line is busy: in 2021, the paralegals answered over 14,000 phone calls and responded to 2,400 online intake requests. The line is open from 8 a.m. to 6 p.m. Monday through Thursday and 8 a.m. to 4 p.m. on Fridays in order to accommodate as many callers as possible, and applicants can access our website form at any time.

The intake paralegals have demanding jobs which require proficiency in LSHV's many practice areas and an understanding of our complicated eligibility requirements. The position requires the patience and compassion necessary to spend all day talking with people in crisis while eliciting the information needed to triage their cases. On a typical day, the paralegals field calls from people fighting evictions, fleeing domestic violence, appealing government benefit denials, and facing the host of other legal issues that LSHV handles. Many of LSHV's funding sources have different eligibility requirements, and the paralegals are well-versed in the intricate requirements for each. In addition to their background in all of LSHV's practice areas, the paralegals are familiar with a wide range of referral resources to provide to callers whose cases we cannot handle.

An exciting development in the Central Intake Unit this year was the creation of an improved online intake form. The new form performs basic triage that allows applicants whose cases involve legal issues that our office cannot handle to receive a list of referral resources automatically. The form also automatically populates our case management system with the information entered by applicants. Both of these features improve the efficiency of the online intake process both for applicants and for the paralegal who responds to the applications.

This year one of the intake paralegals drew on her expertise in LSHV's financial eligibility requirements to take the lead on an agency-wide financial eligibility training, revamping our training materials on the subject and conducting an engaging training for staff. During the training, she walked LSHV's entire staff through real-life examples of financial eligibility assessments and articulated our complicated financial eligibility

screening procedures in a clear and readily understandable way. The intake paralegals also received training this year from staff from the Rockland Pride Center about how to ask our required demographic questions regarding gender and sexuality skillfully and sensitively.

The intake paralegals handle demanding front-line work and carry out their responsibility to serve as clients' first point of contact with LSHV with professionalism and compassion. They are the public face of LSHV, and we are grateful to them for their hard work and dedication.

A Peace of Mind

When Shaniqua came to LSHV in 2020, she was in desperate need of help. Although Shaniqua was working and able to pay her rent faithfully – her living conditions were deplorable at best.

Shaniqua had been living in her apartment for several years and when she came to us during the pandemic, it was out of desperation. She had already come to LSHV for help in the past- help dealing with the same landlord. In 2017 the landlord was ordered to make necessary repairs and Shaniqua ultimately received an abatement, on rent paid, because of the living conditions. She thought all had been rectified and was satisfied that the landlord would do what he had been ordered to do so she could get on with her life. Unfortunately, the landlord never made the necessary repairs.

Fast-forward to 2020 and Shaniqua's apartment is completely inhabitable for her and her young daughter. Whenever it rained, water would come through the ceiling accompanied by maggots – literally dropping from the ceiling. Shaniqua was at her wits end and decided to look for help again. LSHV paired her with one of our volunteers, Pro Bono Lawyer Christopher Conroy. "Christopher was great. In the times I needed to vent or was frustrated, he just listened. He

was almost like a partner and made me feel valuable. He gave me peace of mind." said Shaniqua.

Christopher was able to negotiate a favorable outcome for Shaniqua and her daughter. Shaniqua now lives in a new building and has been able to complete her Master's in Criminal Justice. Shaniqua believes "People should not be afraid or embarrassed to fight for their rights" – there are resources to help you get the results you need to move forward with your life."

This is just one of the stories of the 5,239 housing cases we handled last year that impacted over 12,200 household members. Each year we keep thousands of low-income families in their homes, mostly households with children. Our attorneys provide free legal assistance to prevent foreclosures and halt evictions, preserving the most basic necessity of life – shelter – for as many families and individuals as possible. Although the majority of our services are provided by in-house staff, our pro-bono attorneys help with the overflow and with those cases we can't take for one reason or another.







Government Grants and Special Funding

Legal Services of the Hudson Valley is proud and grateful to have the support of a large number of government and private funders, as well as corporations, law firms, individuals, and our own Board Members, whose generosity makes our work possible. Thank you to ALL!

This year, as both our organization and our clients have worked to recover from the COVID-19 pandemic – which created an unprecedented housing crisis and left thousands of the families we serve at risk of becoming homeless – we are particularly thankful for our partnerships with several private foundations which awarded us funding to provide emergency rental and utility arrears to our most vulnerable clients.

Through grants from Gerstner Philanthropies' Helping Hands Program, the Dyson Foundation, and the United Way of Westchester and Putnam's & the United Way of the Dutchess-Orange Region's Emergency Food and Shelter Programs ("EFSP"), our attorneys were able to "bundle" funding our clients received from the NYS Emergency Rental Assistance Program ("ERAP") and other sources, enabling so many to stay in their own homes and ensuring that landlords received back monies owed to them.

Expanding Access to Legal Services for Tenants in the Hudson Valley

By all accounts, the COVID pandemic exacerbated the housing crisis in the Hudson Valley. Housing instability is the number one reason people seek assistance from Legal Services of the Hudson Valley. In 2021, almost half of the 12,000 cases LSHV handled addressed housing issues. For every tenant we represent in an eviction matter, we turn away two to three other tenants who need assistance.

Tenants are twice as likely to win their case when they are represented by legal counsel. Almost every landlord who brings an eviction proceeding is represented by an attorney. In contrast, well over ninety percent of tenants appear in housing court without counsel. The consequences are dire – families are evicted, they enter into unfavorable settlement agreements, or give up, move out, and become homeless.

Recognizing the impending tsunami of evictions when the moratoria expired, New York State allocated \$25 million of funding to expand the availability of legal representation in eviction cases outside of New York City. Legal Services of the Hudson Valley was awarded \$5,591,018 in funding to increase tenant defense in our seven-county service area. This funding enabled LSHV to fund approximately 20 positions throughout the organization to provide legal services to tenants facing eviction. Additionally, LSHV subcontracted \$1,728,210 of the funding to its affiliate organization, Hudson Valley Justice Center, to increase eviction defense to immigrant communities. Consequently,

Hudson Valley Justice opened an office in Newburgh, in addition to its office in White Plains, to serve tenants in the Mid-Hudson Valley.

2021 Equal Access to Justice Gala Review

We're Back At it! The 2021 Equal Access to Justice Virtual Gala and VIP Reception, was the first fully in-person event LSHV hosted since the start of the pandemic. The gala took place at the Coveleigh Club in Rye, NY. Thanks to the generosity of all the businesses and individuals that contributed to support Legal Services of the Hudson Valley.

We raised over \$300,000 at the hybrid Equal Access to Justice Gala. The in-person reception was held at the Coveleigh Club where over 80 guests, for the first time in a while, enjoyed a true face-to-face networking event. The event honored two outstanding leaders in social justice: Barbara Finkelstein, retired CEO of LSHV received a Lifetime Achievement Award and Senate Majority Leader Andrea Stewart-Cousins was presented the Equal Access to Justice Award. Both women have been trailblazers, glass ceiling breakers, mentors and leaders and true champions of justice.

The emcee for the evening was award winning news anchor and reporter Tara Rosenblum and among the dignitaries present were Senator Shelley Mayer and former Yonkers City Councilman John Murtagh.

The event premiered a new video featuring several clients and staff. Teresa Santiago stepped up to the podium afterwards and told her full emotional story about fighting for extra home-care for her ailing mother during COVID and how LSHV attorney, Patricia Angley, wrapped her in support and fought to get her the help she needed.

CEO of LSHV Rachel Halperin emphasized: "LSHV played an essential role during the pandemic and it continues to be an integral part of the region's recovery from the pandemic. Vulnerable families need continued support to stabilize and recover from the trauma experienced during the pandemic. LSHV is not only an essential part of this recovery but also a wise investment in our communities and residents. In New York State, every dollar spent on civil legal aid creates \$10 in benefits for the recipients of the assistance, their communities, and the state combined. Justice should not be a limited resource that is available to only those who can afford it. Rather, all communities should have equal access to justice so that our communities can fully recover and come through this pandemic even stronger and fairer!"




