Rachel received her J.D. from New York University School of Law and her M.S.W. from New York University School of Social Work. She received her B.A. in sociology from the University of Pennsylvania. Williams, a federal class action lawsuit initiated in 2000 on behalf of victims of domestic violence and their children, and the subsequent appeal, Nicholson v. Scoppetta.

In addition to her responsibilities managing the legal program of the White Plains office, Joanne's job duties include coordination and substantive supervision of domestic violence legal services program-wide, guiding the professional development of staff regarding domestic violence work, and serving as a resource about DV-related issues to all Legal Services of the Hudson Valley staff and justice communities.

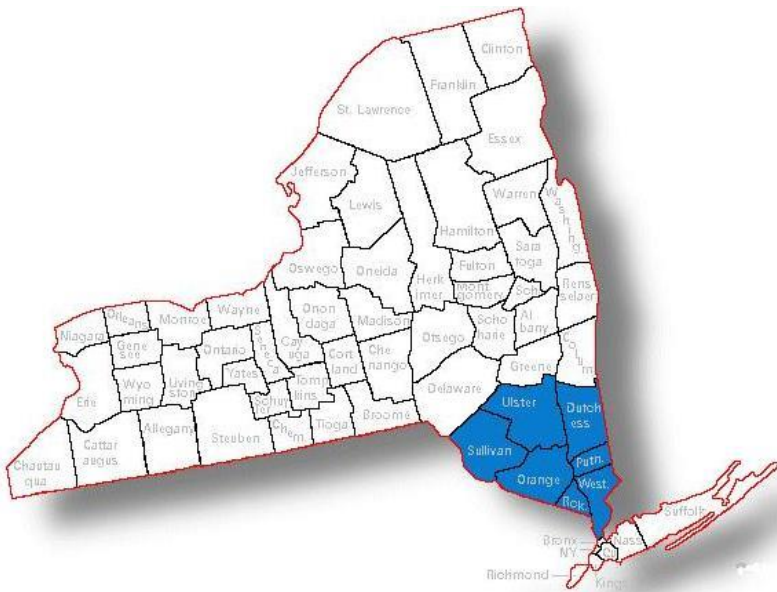
